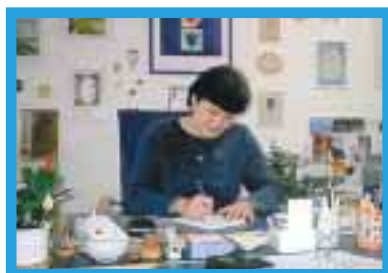


# ČRDM

# Annual report (summary) 2002

Czech Council of Children and Youth (ČRDM) in 2002 was composed of 45 non-governmental children and youth organisations with almost 180.000 individual members – the organisations range from very small to the biggest ones.

## BAMBIRIÁDA 2002

This large presentation of children and youth's activities took place for the 4<sup>th</sup> time at the end of May in 14 towns and cities throughout the whole Czech Republic, under the auspices of several ministers of the Czech government and local authorities. During its 4 days it was visited by 140.000 visitors, which shows its popularity. Bambiriáda is ČRDM's most important contribution to the support of non-formal education of children and youth, the organisations working for them and their public presentation.

## OTHER PR AND LOBBYING ACTIVITIES

**Award of the ČRDM "Přístav"** - The award is intended for local administration's politicians for their support of the non-formal educational activities of/ with children and youth. It was awarded to seven politicians, who can be a good example to the others.

**Work on the "Act on work with children and youth"** - This act should be the basic rule for the organisations working with children and youth and is being prepared for some years now. In 2002 ČRDM delegated its representative to the workgroup of the Czech Ministry of Education, Youth and Sport, who submitted lots of our important points of view into the draft of the act.

**Meetings with politicians** - ČRDM invited several interesting politically active personalities to meet young people, answer their questions and share their ideas about youth work and its importance in today's society with them. ČRDM's workgroup "State" held many discussions with politicians to get their support and to lobby for an acceptable legal environment and reasonable regulations for youth work.

## PUBLICATIONS

**ARCHA** - In 2002, ČRDM published 10 issues of Archa - our information magazine about education and use of the spare time of children and youth. Every issue had different main theme, 3 specialised supplements were published.

**Methodical publication "Safety rules for the activities with children and youth"** - second edition of this very useful and highly demanded publication was published.

**Internet** - ČRDM cooperated with the National Youth Information Centre (NICEM) on the running of the on-line information portal Adam.cz - the main "meeting place" of children and youth's associations with the public. Other ČRDM's Internet projects is Sidliste.cz – a drug prevention portal, and the website of ČRDM - [www.crdm.cz](http://www.crdm.cz).

## INTERNATIONAL ACTIVITIES

In 2002, ČRDM has widened its international activities. It became member of two international networks - EAICY (European Association of Leisure Time Institutions of Children and Youth – [www.eaicy.cz](http://www.eaicy.cz)) and PREMJer (network of european regional and national youth councils – [www.premjer.net](http://www.premjer.net)) and took part in their activities.

ČRDM continued in running the Internet server **Evropa.adam.cz**, which informs young Czechs about Europe and their possibilities there, and started to inform about Czech youth in English on the server **Czechyouth.adam.cz**.

During the Bambiriáda festival, ČRDM organised the second **Meeting in the Heart of Europe**, attended by young people from the neighbouring countries of the Czech Republic and from Slovenia.

ČRDM was also represented on various events abroad ("13410s" in Hungary, YOUROPA in Denmark, Forum for Children and Family, Conference of ministers responsible for youth from the countries of Council of Europe). ČRDM was active in implementation of the European Commission's White Paper on Youth and other activities related to this topic. It was also present at the General Assembly of the European Youth Forum in November.

ČRDM has a good cooperation with the Youth Council of Slovakia (RMS) - our representatives attended RMS' Young Parliament and its general assembly. ČRDM was also represented in the Czech-Slovak commission for youth cooperation and in a similar commission for cooperation with Germany.

## SUPPORT OF THE ASSOCIATIONS

**Insurance** - As in the years 2000 and 2001, ČRDM arranged and administered casualty, travel and liability insurance for children and youth's associations (not only the member organisations) with the Generali Insurance Company.

**Seminars** - ČRDM organised seminar for accountants of associations and a series of seminars and discussions as a part of the "Big Mutual Exchange of Experience" – meeting of several hundreds of youth leaders.

**Service for the associations** – In ČRDM's Office 4 full-time employees devoted their time and skills to the service and support of member organizations.
